I have worked extensively for Marriage equality in Ohio, Arizona, Maryland and D.C., and would not consider supporting any effort to take away those rights given to the citizens of the District of Columbia. I am publicly in support of equal marriage rights for all, and will stay this way even should an effort rise to take these rights away.
- 2. Yes. As a supporter of marriage equality, I would work tirelessly for the act to be reinstated. I was actively involved in Arizona in raising money and organizing a grass roots campaign to fight Prop 102.
