## GAY AND LESBIAN ACTIVISTS ALLIANCE OF WASHINGTON DC 2015 QUESTIONNAIRE FOR DC COUNCIL CANDIDATES

- 1. Yes, I fully support the DC legislation that repeals the Armstrong Amendment and prohibits conversion therapy. The Armstrong Amendment violated freedom of association based on the content of the speech about LGBT rights. Conversion therapy is based on junk science and should not be tolerated as science or enshrined in law.
- 2. Yes, given that there seem to be many safeguards. However, I am concerned that poor and disadvantaged women, those with few employment and financial options, will be become habitual surrogates.
- 3. I believe that HAHSTA should focus on teaching prevention in schools and community centers to youth from age ten by teaching them the risks of sexually transmitted diseases. We need to teach the youth that the diseases can be transmitted by people of all sexual orientations.

Additionally, because our community has so many families of different cultures from all over the world, HAHSTA needs to institute education programs for parents whose beliefs regarding sexuality keep them from acknowledging the many gender identities that exist or that adults and youth have sex outside marriage. Parents' beliefs about sexuality may hinder their children's education about sexually transmitted diseases because they refuse to believe that their children are sexually active in the face of evidence of such activity. Additionally, parents of certain cultures may refuse to recognize that their children may be gay or shame the children because there is evidence that they are not heterosexual. All of these behaviors may drive the youth to fail to get tested or hide any diseases that they may contract.

- 5. Yes; I believe all underserved and hard to reach populations, including the LGBT population, should be targeted to provide improved health services, including mental health and drug abuse treatment.
- 6. DC MPD should systematically collect and report crime statistics identifying crimes which exhibit any evidence of hate crime, including any crimes which appear to be directed to the LGBT community.
